

## Village Fair Regents Park – The Essentials of a Merry Christmas Competition

- 1. The competition commences on Monday 24 November 2025. Entry in-Centre and online closes on Monday 15 December 2025 at 3.30pm. The competition will be drawn at 10.00am on Tuesday 16 December.
- 2. Only entries on an original Entry Form will be accepted as a valid entry in-Centre OR online entry via the official online entry form with upload of receipt.
- 3. Entry Forms may only be distributed by a tenant of Village Fair Regents Park when \$10 or more is spent by the customer at any food, specialty store or service provider or \$50 at Drakes, in one transaction on any one day.
- 4. Only one (1) Entry Form will be provided per person, per transaction.
- 5. Each Entry Form is counted as one (1) entry and may not be used more than once.
- 6. Prize pool consists of 6 Grocery Prize Packs, including:
  - a. \$200 Drakes Supermarket Gift Card
  - b. Christmas Ham from Zac's Continental Butchery, valued at \$100 each.
  - c. The total Prize Pool is \$1,800
- 7. The prize is subject to any terms and conditions defined on the retailer gift cards and vouchers. The Christmas Ham must be collected from Zac's Continental Butchery by 3.00pm on Wednesday 24 December.
- 8. Prizes are not transferable or exchangeable for cash.
- 9. The Winners are be notified by phone on Tuesday 16 December.
- 10. Customers must be 18 years or over to enter.
- 11. Proof of identification is required to collect the prize.
- 12. Prize Packs will be collected from Village Fair Regents Park.
- 13. The following persons are not eligible to enter the competition:
  - a. Tenants of Village Fair
  - b. Employees of tenants of Village Fair
  - c. Contractors of Village Fair and their employees
  - d. Immediate family members of any of the above i.e. spouses and children.
- 14. The winners consent to having their name used and photograph taken, for advertising purposes.
- 15. The competition will be drawn by a representative of Village Fair, whose decision will be final, and no correspondence will be entered into.
- 16. The competition is promoted by Village Fair located on the corner of 3358 Mount Lindesay Highway, Regents Park QLD 4118.
- 17. All entry forms remain the property of the promoter at all times. In lodging an entry, all entrants consent to their names being entered into a database and accept that maintaining their anonymity is not practicable in the circumstances.
- 18. For the purposes of compliance with applicable Privacy Legislation, entrants are advised that: they can contact the promoter for details of the information held about them at the address of the promoter stated above; the purpose for which the information on them is being collected is for marketing purposes related to the promotion of Village Fair and its retailers; the information on them is not usually disclosed to third party organisations; failure to provide all the information required to make a valid entry will result in their entries being ineliaible to be a winning entry form.
- 19. The promoter expressly disclaims any responsibility or liability whatsoever for injury or loss to any person or property relating to the delivery and/or subsequent use of the prize awarded.
- 20. This promotion does not have a direct or indirect association with the sale or consumption of a smoking product or of smoking products generally. Therefore, in accordance with applicable State Legislation, purchases of smoking products are not considered valid purchases for the purpose of this promotion and therefore are excluded from being used to form an entry.
- 21. Receipts from payment of Accounts cannot be used to form an entry. Purchases of prescription medication and gaming related products are excluded from being used to form an entry.
